The van prize is offered "as is" after the completion of reconditioning services performed by AMS Vans of Atlanta, GA. Entries must be completed in its entirety and received electronically at advocateaimee@gmail.com by February 7, 2019. No exceptions. Entries will be reviewed, and one winner will be selected solely by Aimee Copeland by 3/1/2019. Winner must claim the vehicle prize and provide verification of personal identification for the winner and a copy of the license and proof of vehicle insurance for the driver of the vehicle. Winner may take possession of the vehicle at AMS Vans, located at 6275 Lawrenceville Hwy, Tucker, GA 30084 or arrange for vehicle transportation at their own expense. Van giveaway will include free oil changes and tire rotations during the winner's ownership of the vehicle.
